- PROFESSIONAL MEMBER** – Individuals engaged in human resource management with at least three years of experience at the exempt level, or any individual certified by the Human Resource Certification institute; or any faculty member with three or more years experience holding at least assistant professional rank in HR; or full time consultants with at least three years experience as an HR practitioner; or full time attorneys with at least three years experience in counseling and advising clients on matters relating to the HR profession. Professional Members have voting rights and may serve on the Board of Directors in accordance with Chapter Bylaws.
- GENERAL MEMBER** – Individuals engaged in human resource management at any level who do not meet the requirements for Professional Member. General Members have voting rights and may serve on the Board of Directors in accordance with Chapter Bylaws.
- ASSOCIATE MEMBER** – Individuals engaged in professions related to human resources or with an interest in HR. Includes individuals working for staffing, placement or outplacement agencies; insurance agents or benefits consultants; and educators other than those qualified to be Professional members. Associate Members have voting rights and may serve on the Board of Directors in accordance with Chapter Bylaws.
- STUDENT MEMBER** – Individuals enrolled in the equivalent of six (6) credit hours per term in a degree seeking program with coursework, taken or planned, that supports a demonstrated interest in Human Resource Management. Student Members do not have voting rights. *(Students will be required to acquire a Student SHRM Membership.)*
